1. Is the Pre-Bid meeting in person or is it virtual only? If virtual, can you provide the link or invite? If in person, can you verify the address?

2. Will the district extend the due date by at least 10 days, making the due date minimally Friday, February 16th or later? The turnaround time to make any edits to proposals after receiving answers to any questions is very tight.

3. Page 43 and Pricing Pages: Can you please explain the structure for pricing in regards to runs and routes mentioned throughout the documents? A "run" is stated as being at a 1 hour maximum. Is price per "run" based on a single tier route?

Yes, based on a single tier route.

Would a two-tier route be paid twice the rate, or would it be based on a "run" price with excess hours over the 1 hour?

Two tier routes would be twice the rate.

4. Typically, a run (single tier) can be completed in an average of about 40-45 minutes after leaving the school. Do your bell times accommodate for a bus to arrive on time at the second school/tier? If not, will this issue increase the number of routes the district will need to operate to get to all schools on time?

The School District can provide anticipated bell times for any route upon request. All busses must arrive on time for the second school/tier. Each proposer will be responsible for preparing a proposal that accounts for timely transportation of all students.

5. Will the district require an original and five copies of our proposal book for each of the contracts (18 total proposal books) or can we submit one set of proposals for all RFP's with separate pricing tabs for each contract (6 total proposal books)?

Proposers may submit one set of proposals for all RFP's with separate pricing tabs for each contract (6 total proposal books).
