Federal Student Aid

Definition: Federal Student Aid is financial assistance offered from the federal government to help students pay for college.

To be considered for federal aid, you first need to complete a FAFSA (Free Application for Federal Student Aid) at <u>www.fafsa.gov</u>



WHAT DO I NEED FOR THE FAFSA APPLICATION?

- Federal tax return information (Ex. The 2022-2023 FAFSA requires 2020 tax information).
- W-2 forms
- Social security number
- Name of college or university you plan on attending

**If you are deemed a "dependent" student, you will need to provide all the above listed information for your parents as well.

Once a FAFSA is processed, your college or university may ask you for further information.

Once you finish creating an FSA ID, you will need to return to the <u>FAFSA</u> website and accept the terms and conditions.

Afterwards, select the year you are hoping to receive federal aid.
 *Remember that Fall is the first semester of the academic year and
 Spring is the last. Ex. The 2022-2023 FAFSA will apply to the Fall 2022 and
 Spring 2023 academic year.

New York State Aid

Definition: New York state Aid is financial assistance offered from the New York state government to help students pay for college.

Most common New York state programs:

<u>Tap</u>: Tuition Assistance Program. State assistance paying for college tuition for qualifying students. <u>TAP application</u>

<u>Aid for Part-Time Study</u>: State assistance paying for college for qualifying part-time students. *Application available at participating college's Financial Aid Office

<u>Excelsior Scholarship</u>: State assistance paying for college for qualifying students. <u>Subscribe to be</u> notified when Excelsior application is available

To be considered for New York state financial aid, you must complete the designated application for the program you are hoping to receive aid from.

WHAT DO I NEED FOR THE TAP, AID FOR PART-TIME STUDY, AND EXCELSIOR SCHOLARSHIP APPLICATIONS?

- New York State tax information (Ex. The 2022-2023 Tap, Aid for Part-Time Study, and Excelsior Scholarship applications require 2020 taxes).
- Social security numbers.
- Name of college of university you plan on attending as well as your student I.D. for that college/university.

**If you are deemed a "dependent" student, you will need to provide all the above listed information for your parents plus their driver's license/personal I.D. number.

 Once a state application is processed, HESC (Higher Education Services Corporation) may ask you for further information.

Things to Remember

- You must apply for federal (FAFSA) and state (TAP, Aid for Part-Time Study, and Excelsior Scholarship) aid every year.
- You must continue to meet federal standards to receive federal aid and you must continue to meet state standards to receive state aid.
 - It takes time to process your applications. It usually takes 5-10 business days for the Department of Education to process your FAFSA. Each New York State program has varying processing times and lengths.
- Just because you submitted your financial aid applications, does not mean that you are done. You should follow up with your school's Financial Aid Office to make sure you have satisfied all requirements.
 - When in doubt, call your school's Financial Aid Office.
